"MARCELO DASCAL" PRIZE ON COGNITIVE SCIENCE – 2015

Submission Rules

The work submission for applying to the "Marcelo Dascal Prize on Cognitive Science 2015" should fulfill the following criteria:

- Each author may submit only one work (as either single author or co-author).
- Students may submit only works linked to a Graduate Program in Higher Education Institution, national or foreign.
- Fellows with master's or doctorate (PhD) degrees may submit if have obtained the degree for at most three years.
- Only original works will be accepted. Works submitted for publication will not be accepted.
- The work should conform to the theme of the EBICC-2015 "Situated Embodied Cognition: Information and Autonomous Action" in accordance to one of the following tracks:
 - ✓ Cognitive Architectures.
 - ✓ Cognition Modelling.
 - ✓ Information and Cognition.
 - ✓ Perception, Action and Attention.
 - ✓ Language and Cognition.
 - ✓ Semiotics and Cognition.
 - ✓ Logics, Information and Intelligence.
 - ✓ Mind, Information and Cognition.
 - ✓ Cognition, Technology and Action.
- The work should be written in English, Spanish or Portuguese.
- Entries must contain 15 to 20 pages, including bibliography and notes.
- Papers will be evaluated by a committee of experts, Brazilian and foreigners, according to the following criteria:
 - ✓ Originality.
 - ✓ Relevance.
 - ✓ Theoretical consistency.
 - ✓ Clarity, relevance and achievement of objectives.
 - ✓ Conclusions: foundations, coherence and scope.
 - ✓ Quality of writing and organization of the text (spelling, grammar, clarity, objectivity and formal structure).

- Works must be submitted in electronic format, typed in Microsoft Word for Windows program, with Times New Roman 12 and 1.5 cm spacing between lines and paragraphs.
- It is suggested to follow the following format:
 - ✓ title and subtitle (if any), colon separated;
 - ✓ full name of the authors, the institution for which they work (or last institution in which had affiliation) and their electronic addresses (emails);
 - ✓ a summary in the same language of the text, which should not exceed 250 words, followed by keywords (3-6);
 - ✓ abstract in English, when the text is not in this language.
 - ✓ quotes from up to three lines must be enclosed in double quotes; single quotes are used to indicate quotation within quotation. Quotations with more than three lines should be highlighted with a decrease of 4 cm from the left margin, Times New Roman 11 and without quotes. Deletions in quotes should be indicated by ellipsis in square brackets, and interpolations or comments should come brackets. To emphasize the quote passages, one should highlight them indicating this change with the words "emphasis added" in parentheses following the call of the quotation, or "emphasis added" if the highlight is already part of the work consulted. Citations can be indicated in the text by number calling system (referring the reader to footnotes) or author-date.
 - ✓ footnotes, which can be reference explanatory or include indications, observations and additions to the text should be numbered consecutively in Arabic numerals, the number of call high in the text, after the score that closes the quote, and repeated at the beginning of the corresponding note. The text of the footnotes should be composed in Times New Roman 10.
- At the end of the text, should be indicated the bibliographic references consulted. A generic sequence of the essential elements of a bibliographic reference can be represented as follows: AUTHOR. Title. Translation (if applicable). Location: Publisher, date.
- Authors who have already been awarded the First Prize in earlier editions of *"Marcelo Dascal Prize"* may not submit work.
- There will be prizes for first and second place.
- Advisors and teachers should *not* have active participation in the drafting of text.
